PLANNING THE PHOTOGRAPH SESSION

A PLANNING AND CONSULTATION MEETING between the clients and photographers is a very important first step to a successful photographic session being completed. The client is able to voice their concerns and the special needs they may have when it comes to the event such as a wedding or a special event as may occur in their lives. These matters must be agreed upon and the following are suggestions which will spell out what most people would like to see occur in the photographing of their wedding. An agreement, as pertains to the freedom of presence with regard to the photographic activity of the photographers is important. We require an advance payment of 50% as demonstrates good intention, and a serious attitude about getting a job well done. Again, I stress how important a planning session is as we invite the Bride and Groom and others. The same principles apply, in all events or sessions, as may be anticipated, thus causing a successful outcome.

“SUGGESTED WEDDING PHOTOGRAPH SEQUENCE”

THE INITIAL CONSULTATION MEETING will discuss the following suggestions and give us your special needs and needed permission to photograph in special manner. Truly it is important, that a clear understanding is achieved and that the clients, both Bride and Groom’s special needs, are voiced in this session... It is also a session whereby the clients give permission to all photographic techniques. The photographers must feel unrestricted in their movement if possible, in the photo session, and thus avoid any embarrassing restrictions of movement that may be later expressed by Bride, Groom or Minister as he officiates the wedding ceremony. -THE FOLLOWING IS SUGGESTED!

- (1) Arrival Scene (Location entry & empty church interior)
- (2) The Bride’s quiet and unseen preparation prior to entry.
- (3) Photograph arrival of guests (individually and couples)
- (4) Entry of wedding party and awaiting Minister etc..
- (5) Photograph attendees as gathered in church seated: for Bride and for Groom.
- (6) Photograph “ring bearers” and “Best Men and Brides Maid parties” assembled.
- (7) Entry of Bride down aisle as escorted in give-away walk.
- (8) A 360 degree series of photos as ceremony in progress.
- (9) Special photo emphasis on the “exchange of rings” as slipped on the fingers.
- (10) Series of photos re/exit now newly wedded husband and wife.
- (11) Photos of newly married couple as appropriately posed-individually.
- (12) Photos of all in wedding party following wedding ceremony with family and options of all the wedding ceremony participants and newly wedded couple.
- (13) Photographs of “Marriage Certification being witnessed”.
- (14) Individual photos of departing guest as is appropriate.

- (1) Arrival at reception location (physical site).
- (2) Arrival at reception location as wedding party exits from vehicle.
- (3) Arrival of newly married couple as exit from vehicle.
- (4) The guest book as is hosted and signed by guests.
- (5) The wedding party participants as are assembling in reception hall.
- (6) The necessary photos of gift tables, food tables & wedding cake prior to cutting.
- (7) The social or cocktail hour, as attendees mingle with the wedding party.
- (8) Photograph meal as served and entertainment present or available.
- (9) The official cutting of the wedding cake.
- (10) The Groom toasts the Bride and wedding party and guest assembled.
- (11) Dance and entertainment and guest photographed as follows balance of session
